Shortcuts to exclusive annotations of the Criminal Code and related Criminal Statutes and leading commentary from Canada's judiciary, counsel, and academics are available from the CriminalSource homepage. CriminalSource also features all criminal and criminal-related legislation and regulations relevant to the practice of criminal law.

It was in early October 1981 when Judge Maddison arranged to have me work in the Yukon Public Law Library.

After a very casual interview with him in his chambers, I started working in the Law Library on October 5th. There had been a mail strike in the summer and fall of 1981, and the mail was piled high on every flat surface in the library. There hadn't ever been any trained library staff up to this point...what a gold mine for a young library graduate!

The Yukon Public Law Library has been

collection for the Department of Health and Social Services.

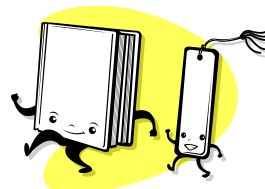
She is enjoying her new position at YPLL and is looking forward to meeting all of you.
